Specifically:</p> <ul style="list-style-type: none"> • On March 23, 2017, Pi Kappa Alpha received an informal disposition, which included sanctions to be completed before the end of the semester, specifically May 1 and May 20. • As of July 17, 2017, sanctions #2 and #3 from the March 23 letter have not been completed. Records from the Office of Student Conduct and the IFC VP of Risk Management indicate that these sanctions were not completed. This is a direct contrast to what you reported during the June 12 meeting. • As of July 17, 2017 the \$250 judicial processing fee has not been paid. I confirmed this in an email to you on June 12 following our meeting. 	<ul style="list-style-type: none"> • <u>Disciplinary probation until 12/15/2017</u> • <u>Loss of privileges</u>—Pi Kappa Alpha is prohibited from hosting or participating in any events with or without alcohol with the exception of the following <ul style="list-style-type: none"> ○ Chapter meetings and new member meetings—during these meetings a member of the alumni advisory board must be present. • <u>Loss of privileges</u> - No alcohol of any kind will be allowed in the chapter facility effective immediately and until the sanctions from the March 23, 2017 decision letter have been completed and the judicial processing fee paid.
